Hunting Lease Liability provides protection for occurrences arising out of activities and operations of the hunt club and its members, guests or invitees on acreage leased to the hunting club by the woodland owner.

Combined Woodland Owners Liability and Hunting Lease Liability provides both types of coverage. This coverage is available to woodland owners who lease all their property to one hunting club.

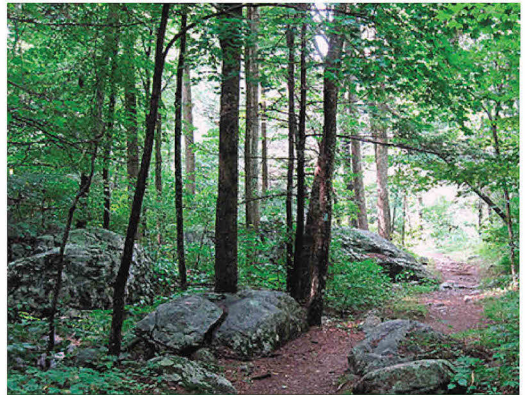
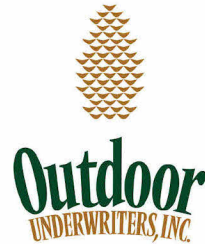
